2. General Criteria

The proposed community sponsorships that meet MVP's geographic criteria will be evaluated against and prioritized according to the six general criteria listed below.

- Tangible, measurable benefits associated with the partnership.
- Opportunity to create value.
- Ability to reach targeted audiences and build key relationships.
- Positive exposure for the MVP brand.
- Potential to be coordinated with other MVP initiatives; and

 Supports a current relationship by an MVP employee who volunteers time serving on the organization's Board of Directors or in another leadership capacity.

- For-profit business organizations;

- Specific benefits MVP will receive from the sponsorship at various levels of support. (Note: a range of options provides greater flexibility to determine potential support);
- Information about the population and geographic location your organization serves:
- List any other committed sponsors of the event/program and the level(s) of those commitments;
- Please indicate whether other health benefits companies are committed or have been approached to sponsor the event/program; and
- Please indicate whether your organization is a current customer of MVP Health Care.
- Please indicate if an MVP employee sits on your board or volunteers for your organization. If yes, please identify the MVP employee and his/her role with your organization.
